

# Pioneer Public Television (PPTV) Online Privacy Policy

August 2007

We have created this privacy statement in order to demonstrate our commitment to the privacy of any information you may provide to us. This policy discloses our information gathering and dissemination practices for this web site: [www.pioneer.org](http://www.pioneer.org), as well as any other web sites owned or operated by PPTV.

We will do our very best to ensure the privacy of any identifiable information (such as full name, address, e-mail address, telephone number and/or other identifiable information) you may provide to us.

## Information We May Gather:

1. Our web servers will create log files which contain all or some of the following information:
  - a. The date, time and length of your visit
  - b. The path taken through our Web site and the browser being used.
  - c. The list of files downloaded and the amount of time spent viewing any video or audio files
  - d. The Internet Protocol Address (IP Address) of the computer accessing our Site. We use your IP address to help diagnose problems with our server and to administer our Web site.
  - e. Any errors encountered.
  
2. We will not collect personally identifiable information from you, other than what you supply to us on a voluntary basis. However, in order to participate in some activities, you might be asked to provide some personally identifiable information. This could be in connection with the following:
  - a. contest registration
  - b. subscription registration for sites or services which require subscription (such as e-mail newsletters).
  - c. requests for membership information
  - d. fulfillment of your orders for merchandise
  - e. gathering your editorial comments and feedback
  - f. content submissions, comments and suggestions, or voting
  - g. On-line surveys. The information you may provide in these surveys is used only on an aggregate basis to describe our audiences and assist us in better serving you.
  - h. Participation in community postings, bulletin boards or "chat rooms"

3. Except in the event that you violate the [PPTV Terms of Use Agreement](#), PPTV will not willfully disclose your personal information received online to any third party without first receiving your permission.
4. PPTV may use your personally identifiable information for the activities explained above and for internal and marketing promotional purposes.
5. Subject to your approval, PPTV may include some or all of the personal information gathered above on lists which we may make available to well established charitable, cultural non-profit organizations. Please refer to the "[PPTV Policy Regarding the Exchange of Member Lists](#)" for further information. We do not share, exchange, rent or sell any of our lists to political parties or candidates for political office.
6. If you do not want personal information which you voluntarily supply used by us for these purposes, you can simply "opt out." Please note, however, under certain circumstances, opting out may prevent your participation in activities for which personal information is needed, as in contests.
7. When you engage in financial transactions at our Site, you may be asked for a credit card number. These sections of our web site are secure and protected by Info-link Wireless Inc. and their Verisign account.
