THE EXECUTIVE COMMITTEE SHALL AID AND ADVISE THE PRESIDENT IN MATTERS CONCERNING THE AFFAIRS OF THE CORPORATION, ASSESS THE PERFORMANCE OF THE PRESIDENT ON AN ANNUAL BASIS, REVIEW THE ANNUAL BUDGET AND MAKE RECOMMENDATIONS TO THE BOARD ON BUDGETING MATTERS.
