Meeting Call to Ms. Wright called the meeting to order at 4:04 PM *Order*

Consent Agenda Items On a motion by Mr. Salmon, duly seconded by Ms. Groft, and hearing no discussion, the consent agenda of minutes and notes listed below was unanimously approved by the Board of Trustees.

Finance Committee

Ms. Dixon and Ms. Raskin noted the highlights.

- WMHT's fiscal year is from July 1 through June 30th.
- o After 6 months, WMHT continues to be on track to make its budget net income before depreciation is \$112,058 higher than the budget.
- Operational income is \$155,356 lower than budget.
- o CPB Grants are \$16,897 higher than the budget.
- Full year FY25 CPB grants will be higher than budget by \$33,794 due to the adjustments in the CPB formulary
- Membership (including matching gifts) is \$79,163 lower than the budget.
 Membership is at 97% of the goal.
- Sustainer income (\$965,512) makes up 39% of December's YTD membership revenue.
- Underwriting is \$47,025 lower than budget.
- Operational expenditures before depreciation are \$267,414 favorable to budget. Lapsed salary savings account for \$200,619 or 75% of the favorable variance. Another favorable variance is maintenance and repairs at \$39,427.
- Balance Sheet cash is \$430,166 higher than the prior year due to the WMHT reserve account - realized gains and interest (\$117,457) along with operational savings (\$313,149).

The investment committee meets with our investment advisor, Graypoint, on January 29th.

On a motion by the Finance Committee, the trustees accepted the financial report and December financials.

Governance Committee

Ms. Groft spoke about the election of a trustee to the Executive Committee as allowed by the bylaws. The Governance and Executive Committees met to discuss and agreed to ask Mr. Del B. Salmon to join. Mr. Salmon accepted.

On motion by Ms. Malesardi. Duly seconded by Ms. Opalka, a motion to nominate Del B. Salmon for the Executive Committee was unanimously approved by the Board of Trustees. Mr. Salmon abstained.

Ms. Groft reported on the board orientation that took place on January 15th. The orientation was well received and is a great benefit to all trustees. Materials are on Board Spot.

Ms. Groft reported there will be demographics surveys sent to the board of trustees. The Governance Committee will use this information to ensure diverse representation on the board. The surveys are expected to go out in February 2025.

The board thanked Bridget Ball Shaw for her years of service and her dedication to public media. Ms. Ball Shaw had to step down due to personal reasons.

Institutional Advancement Committee

Mr. Carpenter reported that fundraising and sales are strong. He noted that the first and early second quarters of FY25 did not follow the historical pattern of major giving at WMHT. Mr. Carpenter was thrilled to report that, despite an aggressive December goal, the fundraising staff hit its goal. He shared that membership numbers are very strong at just over 32,000 active members.

Mr. Carpenter concluded his report by acknowledging the retirement of long-time WMHT Senior Advancement Officer, Sandra Beer. Sandra served in her role for 16 years. In that time, she served hundreds of donors well, working with them to grow their giving in support of the organization. He also noted Sandra's remarkable work in planned giving, which is largely responsible for the size of WMHT's Board Designated Fund.

Ms. Fischer Malesardi noted that the Institutional Advancement Committee is going to be meeting between board meetings. The first meeting will take place on February 13th at 2p, over zoom. The committee consists of Jason Benitez, Doris Fischer Malesardi (Chair), Anthony V Hayes, Martin Mbugua, Steady Moono, Livingstone Mukasa, Karen Opalka, Del B. Salmon, Gwen Wright and Teresa Zielinski, along with Patrick Carpenter. The first meeting will be similar to previous years when each IA staff member will meet with the committee and explain what their responsibilities on the staff are. The committee will also meet to discuss board directed funds and the percentage being allocated. The committee will work on the Edison Society. Ms. Fischer Malesardi noted it's a pleasure to serve on this board. Ms. Fischer Malesardi said each trustee is an ambassador for the station.

Mr. Hayes reported on:

Priorities

Threats

Potential threats to federal public media funding are a growing concern.
 These threats are not new, but they are intensifying in ways that are alarming to stations and communities across the country, including WMHT.

Strategy to address threats

- O WMHT will continue to rely heavily on the support of our loyal viewers and listeners. The generosity of this community is amazing. One vital strategy for the future of WMHT is to continually tell the story of the important services we provide and then help current and future members find opportunities to contribute to that work best for them.
- O Diversifying revenue streams through strategic partnerships, member donations, corporate sponsorships and grants is key to our long-term success and sustainability. We will also continue to research and explore new funding models that align with WMHT's vision, mission, and values.
- Partner with national public media organizations to help secure federal funding for public media.

WMHT has been down this road, but public media affects the lives of everyone. Getting information that is unbiased and pure is a challenge without public media. WMHT lifts up our viewers and listeners days. Schools could not do the important work they do without public media. WMHT sits in the belly of the future and together, staff and trustees will make this the best public media station. The new strategic plan shows how to accomplish this, it is the road map to use together. Ms. Wright thanked the governance committee for putting together a group of people who are likewise committed to this mission.
