Digital Transformation Project

Mr. Pedigo introduced WMHT's participation in a CPB funded Digital Transformation Project, A cross-departmental team is working through a customized curriculum designed to help public media stations adapt their organizational culture to more effectively deploy a digital-first, audience-centric approach. The challenge is to reshape program delivery and culture as people increasingly shift from broadcast content consumption to on-demand digital content delivered over multiple platforms.

CEO On-boarding

Ms. Schneider thanked Ms. Piche, Ms. Jimino and the rest of the CEO selection committee. Anthony Hayes will start as the new CEO on January 23. She announced that Ian Berry has agreed to chair an on-boarding committee to help Anthony Hayes connect with key stakeholders and others throughout our community. Ms. Schneider hopes the entire board is engaged, activating its circles, and being an outward facing board.

President's Report

Mr. Altman noted the exciting digital work that was just presented and highlighted special programming coming up on both of our radio stations for Black History Month and Women's History Month. He reported on the work underway funded by our project grant from New York State.
